### **Dance Studio Rules and guidelines for dancers/parents**

At Focus Dance Studio we will strive for excellence in dance and in life. The expectations are for each dancer to continually grow in technique, attitude, work ethic, and discipline. Our goal is to combine fun with learning! We want our studio to be a family! We have seen, first hand, how proud dancers can be when they are in a professional and fun environment! We would love for parents to help us, as instructors/authority figures, to grow their child/dancer in maturity, confidence, and the art of dance. This takes cooperation, communication, and teamwork!

#### **Rules and expectations**

- Dress appropriately and come prepared
- No gum or candy while dancing
- No dance shoes outside the studio or street shoes in the studio
- Don't come late and if you have to, enter quietly
- Respect instructors and fellow dancers at all times
- Don't leave early and if you must, speak with instructor before class
- Don't talk while instructor is talking
- Silence your cell phone
- Listen 1st then ask relevant questions, if needed
- Respect the personal space of others
- Be attentive at all times. Do not sit down unless you are told to do so
- Do not correct another dancer
- Never walk out of class or go sit down because the class is too hard or frustrating. Don't say "I can't"
- Parents will direct all complaints and concerns to Christy only and in a timely fashion. Do not directly address an instructor.

## **Attire**

Ballet/kinder combo class attire:

- Hair pulled back in a neat bun
- dark leotard and tan or pink tights only, skirts or shorts optional
- Ballet shoes and/or pointe shoes
- Tap shoes, if necessary

Hip hop attire:

Comfortable clothes/No jeans

No street shoes

Jazz class attire:

- Hair pulled back
- Black leggings or leotard and tights
- Jazz shoes or foot undies

Contemporary class attire:

- Hair pulled back
- Comfortable clothing
- Pirouettes or dance socks
- No jeans

Failure to comply with studio rules will result in the following:

1st offense - warning to Dancer

2nd offense - contact parent

3rd offense - Dancer may be sent home

Dancers are asked to follow these expectations so we can all have the best class experience. This will enrich their time spent in the studio and will help enhance their learning.

Instructors will, at times, correct posture, fix body lines, or manually move a dancer's body for the purpose of teaching and compliance. Instructors will be allowed to style hair, make-up, and clothes as they see fit for choreography and/or dance style.

Fees are due the 1st of each month. A late fee of \$10 will be added to payments made after the 7th of the month. There are no refunds once payment is made. There is no pro-ration for months that have more or less than 4 weeks. We generally follow the Redmond school district holiday/break schedule.

Focus Studio reserves the right to refuse service to anyone for any reason.

Classes that are dropped will not receive a refund

## ***Focus Dance Studio***

### **RELEASE AND WAIVER OR LIABILITY AND INDEMNITY AGREEMENT**

In consideration of being permitted to participate in any way in the Dance Program indicated below and/or being permitted to enter for any purpose any restricted area (herein defined as any area where in admittance to the general public is prohibited), the parent(s) and/or legal guardian(s) of the minor participant named below agree:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below dance activity or event, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate. I understand and agree that, if at any time, I feel anything to be UNSAFE, I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.
2. I/WE fully understand and acknowledge that:
  - a. There are risks and dangers associated with participation in dance events and activities which could result in bodily injury, partial and/or total disability, paralysis, or death.
  - b. The social and economic losses and/or damage, which could result from these risks and dangers described above, could be severe.
  - c. These risks and dangers may be caused by the action, inaction or negligence of others, including, but not limited to, the Releases named below.
  - d. There may be other risks not known to us or are not reasonably foreseeable at this time.
3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the Releases named below.
4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the dance facility used by participant, including its owners, managers, promoters, lessees or premises used to conduct the dance event or program, premises and even inspectors, underwriters, consultants and others who give recommendations, directions or instructions to engage in risk evaluation or loss control activities regarding the dance facility or events held at such facility and each of them, their directors, officers, agents, employees, all for the purposes herein referred to as "Release"...FROM ALL LIABILITY TO THE UNDERSIGNED my/our personal representatives, assigns, executors, heirs and next of kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES AND ANY PARTICIPANT OR DAMAGE TO THE PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALLEGED TO BE CAUSED IN THE WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASE OR OTHERWISE.
5. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENTS(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASES.
6. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
7. On behalf of the participant and individually, the undersigned partner(s) and/or legal guardian(s) for the minor participant executes this Waiver and Release. If, despite this release, the participant makes a claim against h of the Releases, the parent(s) and/or legal guardian(s) will reimburse the Release for any money which they have paid to be a participant, or on his/her behalf, and hold them harmless.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO BE AND INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
